is said to have a multivariate normal (or Gaussian) distribution with mean $\mu \in \mathbb{R}^n$ and covariance matrix $\Sigma \in \mathbb{S}^n_{++}$ if its probability density function² is given by $p(x; \mu, \Sigma) = \frac{1}{(2\pi)^n |\Sigma|^{1/2}} \exp\left\{-\frac{1}{2}(x-\mu)^T \Sigma^{-1}(x-\mu)\right\}$. We write this as $X \sim N(\mu, \Sigma)$. In these notes, we describe multivariate Gaussians and some of their basic properties.

The Multivariate Gaussian Distribution

In probability theory and statistics, the multivariate normal distribution, multivariate Gaussian distribution, or joint normal distribution is a generalization of the one-dimensional normal distribution to higher dimensions. One definition is that a random vector is said to be k-variate normally distributed if every linear combination of its k components has a univariate normal distribution.

Operations on Gaussian R.V. The linear transform of a gaussian r.v. is a gaussian. Remember that no matter how x is distributed, $E(AX + b) = AE(X) + b$ $Cov(AX + b) = ACov(X)A^T$ this means that for gaussian distributed quantities: $X \sim N(\mu, \Sigma) \Rightarrow AX + b \sim N(A\mu + b, A\Sigma A^T)$. The sum of two independent gaussian r.v. is a gaussian. $Y = X_1 + X_2, X_1 \dots$

Multivariate Gaussian Distribution

The most common way of parameterizing the multivariate Gaussian (a.k.a. Normal) density function is according to $N(x; \mu, \Sigma)$, $\frac{1}{(2\pi)^n} \frac{1}{|\Sigma|^{1/2}} \exp\left\{-\frac{1}{2}(x-\mu)^T \Sigma^{-1}(x-\mu)\right\}$ (1) where $x \in \mathbb{R}^n$ denotes a random vector that is Gaussian distributed, with mean value $\mu \in \mathbb{R}^n$ and covariance $\Sigma \in \mathbb{S}^n_{++}$ (i.e., the n-dimensional positive definite cone).
